

Scotland's Charity Air Ambulance (SCAA) "First Flight" Raffle: Terms and Conditions

Please read these Terms and Conditions carefully before entering SCAA's "First Flight" Raffle.

By entering, all participants agree to be bound by these terms.

1. The Promoter

The promoter of this raffle is Scotland's Charity Air Ambulance (SCAA), a registered charity in Scotland (Charity No. SC041605), with its main address being Scotland's Charity Air Ambulance, Perth Airport, Scone, Perth, PH2 6PL.

2. Eligibility

- Entry is open to individuals aged **18 years or over** at the time of entry.
- Employees of SCAA, their immediate families, and anyone professionally connected with this raffle are not eligible to enter.
- Participants must be **residents of the United Kingdom**.

3. How to Enter

- Entry to the raffle is **free of charge**.
- To enter, participants must complete the official raffle entry form hosted on the SCAA website (<https://www.scaa.org.uk/first-flight-competition/>)
- An **optional donation** may be made upon registering for the raffle, but making a donation will **not** increase the chances of winning.
- Only **one entry per person** is permitted. Multiple entries from the same individual will be disqualified.
- SCAA accepts no responsibility for entries that are lost, delayed, incomplete, or otherwise not received or cannot be entered for any technical or other reason. Proof of submission is not proof of receipt.

4. Raffle Period

The raffle will open for entries on **Thursday 7 August at 12noon** and will close at **12noon on Wednesday 10 September**. Any entries received after the closing date will not be valid.

5. Prize Details

The prize consists of **two seats** for the winner on the inaugural "First Flight" of SCAA's new aircraft, with the named winner able to bring one guest to join them on the day.

5.1 Inclusions

The prize includes:

- Two seats, one for the named winner and one for a guest of their choosing on a flight aboard SCAA's new aircraft lasting approximately **20-minutes**.
- The flight is scheduled to take place on **Wednesday, September 24, 2025** at 11am.
- A unique opportunity to be part of the new aircraft's first official flight.

5.2 Exclusions

The prize **does not** include:

- Travel to and from SCAA's Aberdeen base.
- Any other expenses not specifically mentioned in the "Inclusions" section.
- The prize is **non-transferable**, and **no cash alternative** will be offered.

6. Draw Details

6.1 Draw Date

The draw will take place on **Wednesday 10 September**.

6.2 Draw Method

The winners will be selected at **random** from all eligible entries received using a secure, independently verified random selection process. The decision of SCAA regarding the winners is final and no correspondence will be entered into.

6.3 Winner Notification

The winners will be notified by email and/or telephone within **24 hours** of the draw taking place. If a winner cannot be contacted or does not respond to the notification within **48 hours**, SCAA reserves the right to withdraw the prize from that winner and draw an alternative winner.

7. Winner Requirements & Fitness to Fly

- **Medical Fitness:** All winners must be **medically fit to fly**. By accepting the prize, the winner confirms they are in good health and have no medical conditions that would prevent them from flying safely in a small aircraft. SCAA reserves the right to request a medical declaration or certificate from a qualified medical practitioner if there are any concerns about a winner's fitness to fly.
- **Mobility:** While SCAA will endeavour to accommodate all winners, participants must be able to board and disembark the aircraft independently or with minimal

assistance. Any specific mobility requirements must be declared to SCAA at the earliest opportunity.

- **Identification:** Winners must provide valid photographic identification (e.g., passport or driving licence) on the day of the flight for security purposes.
- **Behaviour:** Winners are expected to behave in a safe and responsible manner at all times. SCAA and the flight crew reserve the right to refuse boarding or remove any individual from the flight if their behaviour is deemed to be a risk to safety or disruptive.

8. Mitigating Circumstances & Force Majeure

- **Aircraft Availability:** The "First Flight" experience is contingent on the availability and operational readiness of the new aircraft. While SCAA aims for the flight to take place on September 24, 2025, unforeseen circumstances, including but not limited to, technical issues, maintenance requirements, or operational demands on the aircraft (as an active air ambulance), may necessitate a change of date or cancellation of the flight.
- **Weather Conditions:** The flight is subject to suitable weather conditions. In the event of adverse weather, the flight may be postponed or cancelled for safety reasons.
- **Cancellation or Postponement:** In the highly unlikely event that the "First Flight" experience is cancelled or postponed for any reason beyond SCAA's reasonable control, SCAA will endeavour to re-arrange the flight at a time and date that suits both parties. However, SCAA will not be liable for any loss or damage whatsoever arising from such cancellation or postponement. No financial compensation will be provided.
- **SCAA's Discretion:** SCAA reserves the right to modify, suspend, or terminate the raffle at any time, for any reason, without prior notice.

9. Publicity and Data Protection

- By entering the raffle, participants agree that if they are a winner, their name and likeness may be used by SCAA for promotional purposes related to the raffle and the charity, including but not limited to, website announcements, social media posts, and press releases.
- Any personal data collected during the course of this raffle will be processed in accordance with SCAA's Privacy Policy, which can be found on their website. Data will only be used for the administration of this raffle and for communication regarding SCAA's charitable activities if the participant has opted in to receive such communications.

10. General Conditions

- SCAA's decision in respect of all matters to do with the raffle will be final and no correspondence will be entered into.
- SCAA reserves the right to disqualify any entry that it believes to be fraudulent or in breach of these Terms and Conditions.
- These Terms and Conditions shall be governed by and construed in accordance with the laws of Scotland, and the parties submit to the exclusive jurisdiction of the Scottish courts.
